- (3) The potential for other participant(s) to act in a negligent manner that might contribute to injury to themselves or others, such as failing to act within their ability to maintain control over an equine.

I freely accept and fully assume all responsibility for the inherent 'RISKS' and the possibility of personal injury, death, property damage or loss resulting from my participation or my child's participation in Equine Activities.

In addition to consideration given for my participation or my child's participation in Equine Activity, I and my heirs, executors, administrators and assigns (collectively called my "Legal Representatives") agree

- To waive all claims that I might have against the HOST (Central Nova Horse & Pony Association)
- To release the HOST from any and all liability for any loss, damages, injury or expense that I or my "Legal Representatives" might suffer as a result of my participation or my child's participation due to any cause whatsoever including any negligence on the part of the HOST.
- To hold harmless and indemnify the HOST from any and all liability for property damage or personal injury to any third party which might result from my participation or my child's participation in Equine Activities.
